O R D E R

1. Pursuant to the order of this Court dated 08.05.2017, Mr. R. Basant, learned Senior Counsel who acted as a Mediator, took up the matter with right earnest and persuaded the parties to arrive at an amicable settlement. It really fructified and eventually the parties settled their disputes with the intervention of the learned Mediator. A Joint Undertaking dated 04.07.2017 and a Joint Compromise Petition dated 04.07.2017 are handed over today in the Court duly signed by the parties, which are taken on record.

2. We are, therefore, inclined to dispose of this appeal in the light of the Joint Compromise Petition, referred to above, arrived at between the parties. Let this Joint Compromise Petition be a part of our order.

3. In the light of the order that we have passed on the basis of the compromise arrived at between the parties, the impugned order stands set aside and as a result thereof the conviction as also the sentence imposed upon Shri Srinivasa Rao Kamma also stands set aside.

4. We record our appreciation for Mr. R. Basant, learned senior counsel, who acted as a Mediator in this matter to enable the parties to sort out their disputes and come to a compromise.

5. The appeal is, accordingly, disposed of.

6. Pending applications, if any, shall stand disposed of.

7. There shall be no orders as to costs.
