UPON hearing the counsel the Court made the following
O R D E R

The latest office report reveals that despite service of notice, some States and Union Territories including Andhra Pradesh, Jammu & Kashmir and Tamil Nadu are still remained unrepresented.

It is also noticed that some States and Union Territories, especially Punjab, West Bengal, Daman & Diu and Andaman & Nicobar Islands, though represented by their respective learned counsel, their counter affidavits have not been filed so far. Similarly, no counter affidavit has been filed so far in respect of M/s. Trimurti Fragrances (P) Ltd.

However, learned counsels appearing for the State of Maharashtra and Andaman & Nicobar Islands, undertake to file their counter affidavits immediately.

Finally, two weeks' further time is granted to the concerned States, Union Territories and other parties, if any, to file their Vakalatnama and Counter Affidavit, as the case may be.

It is also brought to our notice that another identical matter on the same subject being S.L.P. (C) No. 16308 of 2007 titled *Ankur Gutkha Vs. Indian Ashtama Care Society*, is also pending before this Court. We, therefore, direct to tag this matter also along with S.L.P. (C) No. 16308 of 2007.
