O R D E R

1. Leave granted.
2. The matrimonial dispute inter-se the parties has been resolved by deed of compromise signed by the parties dated 28th May, 2019 and placed on record. We are informed that since then the decree of divorce has been granted and the monetary amounts settled in terms of the compromise.
3. The prayer was made before us to take the compromise on record and the parties to be remained bound by the terms of compromise. Further prayer was made that Criminal Case No.240 of 2016 pending in the Court of Additional Chief Judicial Magistrate, Rishikesh, Dehradun be quashed as a sequel to the settlement.
4. In view of what has been stated aforesaid, we are inclined to accept the request and direct the parties should remain bound by the compromise.

5. Further the proceedings in Criminal Case No.240 of 2016 stands quashed.

6. The appeal is accordingly disposed of leaving the parties to bear their own costs.
