O R D E R

This Miscellaneous Application has been preferred to seek correction in the order dated 16.01.2020 passed by this Court in SLP (Civil) No.14621 of 2019 and other connected matters.

The corrections sought are as under:

- a) "Expression '41 months' occurring in sub-para 3 of para 4 of the Circular dated 20.09.2017 issued by the State Government, as quoted at Page 7 of the Order dated 16.01.2020, be corrected and recorded as '11 months';
- b) Similar error occurring in para immediately after the aforementioned quoted portion, at Page 8 of the Order, be corrected and recorded as '11 months'; and
- c) The reference to communication 'dated 15.03.2017' occurring at Page 8 of the Order be corrected and recorded as 'dated 15.05.2017'.

We have heard learned counsel for the applicant as well as the learned counsel for the State.

The corrections sought for are not opposed.

We, therefore, allow this application. The expression "41 months" occurring at two places in the order shall stand substituted by expression "11 months" and the date "15.03.2017" shall stand substituted by the date "15.05.2017".

Let the aforementioned corrections be made in the order dated 16.01.2020.

The Miscellaneous Application is disposed of in aforesaid terms.

Pending applications, if any, also stand disposed of.
