O R D E R

1. Leave granted.
2. The issue which arises for consideration in this appeal also arose for consideration of this Court in C.A. No.14333/2024 @ SLP(C) No.27632/2024 (Anmol v. Union of India & Ors.), wherein this Court passed order dated 12.12.2024.
3. The facts in the present case are almost similar to the facts in that case.
4. For the reasons that we have allowed C.A. No.14333/2024, we are inclined to allow the present appeal.
5. Learned counsel for the respondent(s) states that as per the merit of the appellant in Persons with Disability (UR) category, he should have been admitted in R.G. Kar Medical College and Hospital, Kolkata.
6. We, therefore, direct that the appellant be admitted in the R.G. Kar Medical College and Hospital, Kolkata against a seat reserved for Persons with Disability (UR). It is further directed that if the seat is not available in the said college, taking into consideration the peculiar facts and circumstances of the case and without it being treated as a precedent we direct that a supernumerary seat be created in the said college against which the appellant can be accommodated.

7. With the above observations and directions, the appeal is allowed.

8. Pending application(s), if any, shall stand disposed of.
