O R D E R

The surviving grievance is limited to an amount of Rs. 27,000/-. Though the learned Counsel for the respondents is right in the submission that they did not get full opportunity of hearing before the High Court, we do not think it necessary at this stage to request the High Court to rehear the matter. It is only in the interest of the respondents that the dispute is given a quietus by making the payment of Rs. 27,000/- in full and final settlement of the entire claims. The amount shall be paid within a period of one month from today.

In view of the above and also in view of the steps taken by the respondents, we do not find any willful disobedience on their part so as to proceed under the contempt jurisdiction. The Contempt Petition is accordingly dismissed. Rule discharged.
