Heard Shri Vikram Chaudhari, learned senior counsel appearing on behalf of the petitioner, and also Shri S. V. Raju, learned Additional Solicitor General appearing for respondent Nos. 2 and 3.

As far as the application seeking default bail, we notice that an order of default bail has been declined by the Sessions Judge (Special Court, PMLA) Lucknow. The petitioner clearly has a remedy open to him before the High Court. It is for the petitioner to seek other remedy as available. We only request that if such an application for seeking default bail is filed, the High Court will take it up with the highest level of expedition since the matter
