The enhanced compensation amount, as provided for in Circular dated 22.8.2012, must be paid to the respondents along with interest @ 5% within four weeks from the date of impugned order, i.e., 8th June, 2015, failing which it shall carry interest @ 7%.

In view of our direction that the payment must be made within four weeks, it is expected that there shall be no impediment in the functioning of the petitioners on the lands in question by the respondents.

The present order has been passed in the peculiar facts and circumstances of the present cases as a one time exercise.
