**UPON hearing the counsel the Court made the following
O R D E R**

1. Since affidavit has been filed on behalf of the petitioner in compliance of the orders passed on 20.11.2024 and 25.02.2025, in terms of the said affidavit, the deposit which has already been made with the Deputy Chief Labour Commissioner is required to be disbursed in the bank accounts of the members of the Respondent-Union (who were parties before the Labour Commissioner).
2. In that view of the matter, the details of the accounts, as required, be furnished by the Respondent No.2-Union to the Deputy Chief Labour Commissioner, who shall transmit the amount, as calculated in the affidavit dated 03.03.2025, filed by the petitioner. In case there is a short fall of the amount, the Deputy Chief Labour Commissioner shall ask the petitioner for further deposit and in case, after disbursement of the amount to all the members of the Union, as indicated in the affidavit, the amount is found to be in excess, the said amount be returned to the petitioner. A compliance report in this regard shall be filed within eight weeks from today.
3. Accordingly, the special leave petition is disposed of.

Pending applications, if any, shall stand disposed of.
