O R D E R

This is a transfer petition at the instance of the petitioner-wife seeking transfer of H.M.A.No.17/2017, titled as Paramjeet Singh Chhabra vs. Harpreet Kaur, pending in the Court of Addl.District Judge, Bhatapara, Balodabazar, Chattisgarh, to the Court of Principal Judge, Family Court, Indore, Madhya Pradesh.

The petitioner has sought transfer of the case mainly on the ground of her poor health condition and her inability to travel from Indore, Madhya Pradesh, to Bhatapara, Balodabazar, Chattisgarh, which is at a distance of more than 800 kms., to attend the proceedings of the case filed by the respondent.

Heard learned counsel for the parties and perused the record.

In view of the hardships which will be faced by the petitioner in contesting the case at Bhatapara, Balodabazar,

Chattisgarh and taking into consideration the fact that the petitioner has already filed a petition under Section 125 Cr.P.C. before the Principal Judge, Family Court, Indore bearing Case No.682/2017; petition under Section 23 of the Domestic Violence Act bearing Case No.50094/2017 before JMFC at Indore, and HMA Case No.1040/2017 before the Principal Judge, Family Court, Indore, against the respondent, we deem it proper to allow the transfer petition and transfer H.M.A.No.17/2017, titled as Paramjeet Singh Chhabra vs. Harpreet Kaur, pending in the Court of Addl.District Judge, Bhatapara, Balodabazar, Chattisgarh, to the Court of Principal Judge, Family Court, Indore, Madhya Pradesh, along with all records for its adjudication. Ordered accordingly.

After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
