O R D E R

This is a petition filed under Section 25 of the Code of Civil Procedure, 1908, seeking transfer of Civil Petition No. 139 of 2019 titled as "Sourav Sharma Versus Khushboo Bhardwaj" pending before the Family Court, Sambalpur, Odisha to the Family Court, Chittorgarh, Rajasthan.

Heard learned counsel for the parties.

Learned counsel for the petitioner/wife contends that the distance between Sambalpur, Odisha to Chittorgarh, Rajasthan is about 1300 kilometers and travel to the petitioner/wife along with eight years old child would cause serious inconvenience to her. Therefore, the prayer as made in the petition may be granted.

Learned counsel for the respondent opposed the prayer for transfer of the said case. However, he contents in case prayer is granted the case may be directed to be decided as early as possible on transfer.

Having heard learned counsel for the parties and having considered the facts and circumstances of the case, I deem it fit and proper to allow this transfer petition. Accordingly, Civil

Petition No. 139 of 2019 titled as "Sourav Sharma Versus Khushboo Bhardwaj" is ordered to be transferred from the Family Court, Sambalpur, Odisha to the Family Court, Chittorgarh, Rajasthan.

The transfer petition is, accordingly, allowed.

Let a copy of this order be sent to the concerned Court forthwith to do the needful. The concerned trial Court shall make endeavour to decide the case as expeditiously as possible.

Records pertaining to Civil Petition No. 139 of 2019 be transferred to the transferee Court without delay.
