ORDER

- 1 This transfer petition has been filed by the petitioner - wife for transfer of HMA No A-1988 of 2019 titled "Gagandeep Singh Chadha Vs Harpreet Kaur" from the Court of Principal Judge, Family Courts, Lucknow, Uttar Pradesh to the Court of Principal Judge, Family Court, Kota, Rajasthan.
- 2 The office report indicates that service is complete, but none has entered appearance.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that HMA No A-1988 of 2019 titled "Gagandeep Singh Chadha Vs Harpreet Kaur" be transferred from the Court of Principal Judge, Family Courts, Lucknow, Uttar Pradesh to the Court of Principal Judge, Family Court, Kota, Rajasthan.

- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.
- 5 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 6 Pending application, if any, stands disposed of.
