A W A R D

1. The learned counsel appearing for the petitioner and the learned counsel appearing for the first respondent, on instructions, state that the total compensation payable to the petitioner shall be Rs.16,00,000/- (Rupees Sixteen Lakh) (inclusive of the amount granted under the impugned judgment by the High Court) together with 6% interest per annum on the sum of

Rs.16,00,000/- (Rupees Sixteen Lakh) from the date of filing of the petition till the date of realization. Ordered accordingly. The impugned awards stand modified accordingly.

2. We grant time of one month from today to the first respondent to deposit the amount in terms of the settlement as recorded above with the Motor Accident Claims Tribunal (for short, "the Tribunal") at Raibag. After the amount is deposited, the learned Member of the Tribunal shall pass appropriate orders regarding disbursement/investment.

3. We clarify that the total amount payable to the petitioner will be Rs.16,00,000/- (Rupees Sixteen Lakh) with interest as aforesaid and while depositing the amount with the Tribunal, the first respondent shall deduct the amount which has already been paid or deposited in terms of the impugned awards.

4. The Special Leave Petition stands disposed of in terms of the aforesaid settlement.

5. Court fee be refunded as per rules.
