O R D E R

While disposing of Civil Appeal Nos. 4347-4375 of 2014 (State of U.P. and Ors. Vs. Shiv Kumar Pathak and Ors.) vide Judgment and Order dated 25.07.2017, this Court had observed:-

"We have been informed that 66,655 teachers have already been appointed in pursuance of the interim orders of this Court. Having regard to the entirety of circumstances, we are not inclined to disturb the same. We make it clear that the State is at liberty to fill up the remaining vacancies in accordance with law after issuing a fresh advertisement.

The matter will stand disposed of in above terms."

Thus, protecting the appointments of 66,655 teachers, remaining vacancies were directed to be filled in accordance with law after issuing fresh advertisements.

The submission of the petitioners is that the figure of 66,655 itself was incorrect; that the State was actually in the process of making appointment of 1536 teachers; and that the petitioners ought to be considered in respect of such

appointments.

The submission having been rejected by the High Court and this Court the present Review Petition has been preferred.

Reliance in support of the case of the Review Petitioners is placed on the opinion given by the standing counsel for the State on 19.06.2018, which was already placed on record in the Special Leave Petition as Annexure P-8.

There is, thus, no ground made out for exercise of Review Jurisdiction.

This Review Petition is, therefore, dismissed.
