Our attention is invited to order dated 15th July, 2019 which
records assurance of learned Additional Solicitor General on behalf

of Union of India that six months' time will be required to make compliance with the order of breach is alleged as there are about 71,000 employees involved.

We direct the Union of India to file a detailed affidavit recording compliance with the directions issued by this Court in Writ Petition (Civil) No.210/2013 and Transfer Case (Civil) No.38/2015.

We grant time of eight weeks to the Union of India to report complete compliance with the direction issued. No further time shall be granted.

We permit the petitioner to file rejoinder affidavit, if any, within four weeks thereafter.
