ORDER

1. Leave granted.
2. We have heard the learned counsels for the parties. While the High Court may have been justified in canceling the pre-arrest bail granted to the accused appellant, in the facts of the case, we are inclined to take the view that cancellation of the regular bail granted to the accused appellant was not justified. We, therefore, set aside the order of the High Court insofar as the cancellation of the

regular bail granted to the accused appellant is concerned and direct that the accused appellant shall remain on such bail as has been granted to him by the learned District and Sessions Judge, Uttar Kannada Karwar on 30th December, 2015 in SC No.35/2015.

3. The appeal is allowed in the above terms and the order of the High Court to the above extent is set aside.
