ORDER

Transfer Petition (Civil) No 1282 of 2019

- 1 This transfer petition has been filed by the petitioner – wife for transfer of Divorce Petition No 71 of 2019 titled “Anup Vardhan Vs Sunita” from the Court of Principal Judge, Dehradun to the Principal Judge, Family Court, Karkardooma Courts, Delhi.
- 2 We have heard learned counsel for the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that Divorce Petition No 71 of 2019 titled “Anup Vardhan Vs Sunita” be transferred from the Court of Principal Judge, Dehradun to the Principal Judge, Family Court, Karkardooma Courts, Delhi.

4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

5 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.

6 The respondent would be at liberty to move an application for hearing to be conducted on the video conferencing platform. Any such application shall be duly considered in accordance with law.

6 Pending application, if any, stands disposed of.
