O R D E R

1. The petitioner has filed the captioned petition under Section 406 of the Criminal Procedure Code, 1973 for transfer the case being No. PRC (WP) 78/2020, titled as "Mrs. Susmita Sinha Vs. Atanu Sinha" pending before the First Chief Judicial Magistrate, Kailashahar Dist. Unakoti, Tripura to the Metropolitan Magistrate, Karkardooma Court, East Delhi.
