UPON hearing the counsel the Court made the following
O R D E R

1. I.A. No. 39272 of 2025 in SLP (C) No. 12945 of 2021 has been filed by the petitioners seeking deletion of the names of unserved Respondent Nos. 8, 10, 11, 16 to 18, 21, 23 and 24. We have repeatedly asked from the learned counsel for the petitioner that the consequences may follow against them and the learned counsel is sure that the names of the unserved respondents be deleted. In response, learned counsel has firmly submits that they are not going to be affected. Therefore, their names may be deleted.
2. Considering the aforesaid, at the risk and costs of the petitioners, the I.A. stands allowed. Names of Respondent Nos. 8, 10, 11, 16 to 18, 21, 23 and 24 be deleted from the array of parties at the risk and costs of the petitioners.
3. Amended memo of parties be filed within two weeks.
4. Notice in all other special leave petitions be issued to the private respondents.
5. Dasti service, in addition, is permitted.
6. Interim order to continue till the next date of listing.
7. In the meantime, counter affidavit be filed by the State.
8. List after eight weeks.
