**O R D E R**

Heard Ms. K. Sarada Devi, learned counsel for the petitioner (defendant no.9). Also heard Mr. K. Parameshwar, learned counsel appearing for the respondents who are the plaintiff(s) in the O.S. No.64/2014, pending before the III District Judge, Ananthapuramu.

While issuing notice, an interim order was passed by this Court on 07.02.2020 staying further proceedings in the O.S. No.64/2014. Before that, the petitioner as the defendant no.9 was regularly participating in the said proceeding.

It further appears that the petitioner had also filed the suit bearing O.S. No.19/2015 which is pending before the Court at Ranga Reddy District Court Complex, L.B.

Nagar. The counsel admit that the O.S. No.64/2014 relates to several parcels of family property but the O.S. No.19/2015 filed by the petitioner, relates to only one property.

Insofar as the bonafide of the present Transfer Petition is concerned, the petitioner has failed to disclose the fact that the Transfer Civil Miscellaneous Petition No.643/2014 filed by her husband and father-in-law was rejected by the High Court on 01.12.2014 (Annexure R-1). Similar suppression is also noticed of the order dated 7.12.2017 where the learned Judge by referring to the subject matter of both suits, had directed that the issues be tried by one Court.

Having considered the above and particularly the fact that the petitioner was all along contesting the O.S. No.64/2014 as defendant no.9 and the contested properties in this Suit, I find no merit in this Transfer Petition. Accordingly, the same is dismissed. The interim Order dated 07.02.2020 stands recalled.
