Mr. Devashish Bharuka, learned counsel for the petitioner submits qua the compliance report in respect of (iii) and (iv) of the directions contained in the order dated 14.1.2020 that there are apparently still about 50 teachers from the old pool whose services are not being utilized. On perusal of the compliance report, it is apparent from the new pool sought to be recruited, a number of people did not join. If that be the position and vacancies exist, we see no reason why the remaining persons from the old pool should not be employed. The needful be done within one month from today.

The second aspect raised by Mr. P.C.Sen, learned senior counsel for the applicants is that in pursuance to direction (i) the filling up of vacancies on a regular basis should be completed in a time bound manner. In this behalf the learned counsel for the State of Uttarakhand submits that the Uttarakhand Public Service Commission issued an advertisement on 9th October, 2020 for 571 posts of Lecturers while the Uttarakhand Subordinate Selection Commission issued an advertisement on 13th October, 2010 for 1431 licenced teachers posts. Learned counsel for the Commission states

that the process is expected to be completed in about 3 to 4 months. We take the aforesaid stands on record.

The proceedings stand closed.
