UPON hearing the counsel through Video Conference, the Court made the following

O R D E R

SLP(C) No.14633-14634/2020

Respondent No.1 in both the matters is stated to have already filed counter affidavit.

Service is complete on respondent Nos.2 and 3 (common) but none has entered appearance.

Ld. counsel for respondent No.4 submits that only two page counter affidavit is to be filed and in case matter is ordered to be placed before the Hon'ble Court, Ld. counsel will file counter affidavit in the meantime.

SLP(C) No. 1037/2021

Ld. counsel for the sole respondent pointed out that he has already filed counter affidavit and made a request to place the matter before the Hon'ble Court. As per the office report, no counter affidavit has been filed. In case the counter affidavit has already been filed and found to be complete in all respects as submitted by the Ld. counsel for the sole respondent, the matter may be treated as complete.

SLP(C) No. 1097/2021

As per the office report, respondent Nos.1 and 4 have not filed counter affidavit. Ld. counsel for respondent No.1 pointed out that he has already filed counter affidavit yesterday itself. Ld. counsel for respondent No.4 submits that he has to file only two page counter affidavit.

Service is complete on respondent Nos.2 and 3 but none has entered appearance.

Registry to verify whether respondent No.1 has already filed counter affidavit or not? In case the counter affidavit has already been filed and found to be complete in all respects as submitted by the Ld. counsel for the said respondent then needful be done further.

Ld. counsel appearing for respondent No.1 in SLP(C) No.14633/2020 and 14634/2020 and also in SLP(C) No.1097/2021 submitted that the matter may kindly be placed before the Hon'ble Court on an urgent basis as some stay order is operating against them. Similar request has been made by the Ld. counsel appearing for respondent No.1 in SLP(C) No.14634/2020. In this regard, Ld. counsel appearing for respondent No.4 in these matters submitted that he has no objection in case this Court decides to proceed to list the matters before the Hon'ble Court as respondent would file two page counter affidavit in the meantime.

As recorded herein-above, in case counter affidavit filed on behalf of the sole respondent in SLP(C) No. 1037/2021 and respondent No.1 in SLP(C) No. 1097/2021 found to be complete in that case let all the matters be processed for listing before the Hon'ble Court failing which the matter be listed before this Court on 07.04.2021.
