ORDER

- 1 This transfer petition has been filed by the petitioner - wife for transfer of Matrimonial Suit No 38 of 2018 titled "Deepak Kumar Srivastav Vs Preeti Srivastav" from the Court of Principal Judge, Family Court, Ghazipur, Uttar Pradesh to the Family Court at Buxar, Bihar.
- 2 The office report indicates that service is complete, but none has entered appearance on behalf of the respondent.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that Matrimonial Suit No 38 of 2018 titled "Deepak Kumar Srivastav Vs Preeti Srivastav" be transferred from the Court of Principal Judge, Family Court, Ghazipur, Uttar Pradesh to the Family Court at Buxar, Bihar.
- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

- 5 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 6 Pending application, if any, stands disposed of.
