O R D E R

The present petition has been filed seeking pre-arrest bail in reference to FIR No. 225 of 2019 dated 25.10.2019 registered with Dhebrua Police Station, District Sidharth Nagar, U.P., which was declined by the High Court by order impugned dated 25.11.2019.

It is informed to this Court that the charge sheet has been filed on 19.09.2022 and the petitioner stood retired after attaining the age of superannuation on 31.01.2019.

After hearing the learned counsel for the parties and taking into consideration the material on record and without expressing any opinion on merits/demerits of the matter, the petitioner has made out a case for grant of pre-arrest bail.

Ordered accordingly.

In the event of arrest, the petitioner shall be released on bail on furnishing security of Rs. 25,000/- along with two sureties of the like amount to the satisfaction of the Investigating Officer/Court, as the case may be.

With the aforesaid directions, the Special Leave Petition stands disposed of.
