ORDER

- 1 The instant transfer petition filed by the petitioner-wife, seeks transfer of HMA Petition No 227 of 2020, titled "*Karan Sidhu vs Nisha Panjwani*", filed under Section 13(1) of the Hindu Marriage Act 1955, pending before the Family Court, Tis Hazari Courts, New Delhi to Civil Judge, Senior Division, Kalyan, Thane, Maharashtra.
- 2 Heard counsel for the parties and perused the record.
- 3 It is not in dispute that the marriage between the parties was solemnized on 9 September 2019 at Thane, Maharashtra. Thereafter, the petitioner-wife joined the matrimonial home at New Delhi. The differences arose between the parties in October 2019, which eventually led to filing of cross cases between them at Thane, Maharashtra and Tis Hazari Courts, New Delhi,

including the subject divorce petition filed by the respondent-husband.

- 4 Having regard to the distance between the two places and the hardship likely to be faced by the petitioner-wife in attending the court proceedings at Delhi, but without expressing any views on the allegations and counter allegations made by the parties, the instant transfer petition is allowed.
- 5 The HMA Petition No 227 of 2020, titled "*Karan Sidhu vs Nisha Panjwani*", filed under Section 13(1) of the Hindu Marriage Act 1955, pending before the Family Court, Tis Hazari Courts, New Delhi is ordered to be transferred to the Civil Judge, Senior Division, Kalyan, Thane, Maharashtra.
- 6 The records shall be transferred to the transferee court forthwith. The transferee court shall issue fresh notice to the respondent to cause his appearance.
- 7 The transfer petition is disposed of in the above terms.
- 8 Pending applications, if any, stand disposed of.
