O R D E R

1. The IA No. 234683 of 2024 (application for withdrawal of civil appeals) is jointly filed by both parties.
2. Heard Mr. Mohit D. Ram and Mr. Mohit Chaudhary, learned counsel for the parties.
3. The attention of the Court is drawn to the settlement dated 30.09.2024 appended to the IA No. 234683 of 2024 to point out that the parties have reached an amicable settlement. It is then submitted that the appeals should be closed in terms of the said joint settlement deed, signed by both parties.
4. In terms of the above settlement, as agreed to in Clause 7(iii), the money which is lying in deposit with the Delhi High Court Registry should be released to the parties named in the said clause. The relevant clause reads as under:

"7. TERMS OF SETTLEMENT

XX XX XX

III. That SECOND PARTY (i.e. Bharati Bhargava and Arati Bhargava) are free to get released in their names the amount deposited in High Court Registry by the tenants of terrace [barsati] of 3/13-B, Asaf Ali Road, New Delhi to which FIRST PARTY [Mrs. Madhur Bhargava, Mrs. Gayatri Bhargava and Ms. Shraddha Bhargava] have no objection. The said rents were being deposited in RFA 732/2003."

5. Accepting the above, we close these proceedings in terms of the settlement reached by the parties. The settlement deed dated 30.09.2024 is made part of this Court's order.

6. The IA No. 234683 of 2024 is allowed and the appeals stand disposed of accordingly.
