UPON hearing the counsel the Court made the following
O R D E R

1. We are informed by learned counsel for the parties that pursuant to the order dated 03.11.2023, the petitioner-mother and the children met and had interaction on 2-3 occasions. Thereafter, the petitioner-mother could not meet the children for want of

further directions from this Court. However, she has regularly been interacting with the children through phone.

2. It seems to us that, in the best interest of the children, let the arrangement as directed through para 3 of the order dated 03.11.2023 be continued for the time being. Accordingly, let the custody of the children be handed over to the petitioner-mother on 24.02.2024 from 2.30 p.m. to 05.30 p.m. The children will again be in the company of the petitioner-mother on 16.03.2024 from 2.30 p.m. to 05.30 p.m. at the same venue as was earlier decided.

3. Meanwhile, the cases pending between the parties shall be adjourned till further orders.

4. Post these matters for hearing on 18.03.2024.
