O R D E R

This transfer petition is filed seeking transfer of M.J. Petition No.A2216 of 2019 titled as "Praveen Janardhan Buram Vs. Jhansi Praveen Buram" pending before the Family Court at Bandra, Mumbai to Family Court, Nizamabad, Telangana.

It is submitted by learned counsel appearing for both parties that the parties have almost settled the terms for resolving the issues between them and to withdraw the cases pending in Courts at Nizamabad. It is further submitted that M.J.Petition No.A2216 of 2019 also could be settled and withdrawn if the interim order granted by this Court on 10.6.2020 staying all further proceedings thereon is vacated and it is transferred to the Family Court, Nizamabad.

In the above circumstances, to enable the parties to settle the entire issues and matters the interim order passed on 10.6.2020 is vacated and petition is allowed.

Consequently, M. J. Petition No.A2216 of 2019 titled as "Praveen Janardhan Buram Vs. Jhansi Praveen Buram"

pending before the Family Court at Bandra, Mumbai is transferred to the Family Court, Nizamabad, Telangana. Ergo, the Family Court at Bandra, Mumbai is directed to transmit the entire record to the Family Court, Nizamabad, Telangana.
