Delay condoned.

The National Green Tribunal<sup>1</sup> by its order dated 26 July 2018 disposed of O.A. No. 223 of 2016 in terms of the order which had been passed by it in O.A. No. 6 of 2012 and O.A. No. 300 of 2013 (Manoj Mishra vs. Union of India & Ors.). By that order, the NGT constituted a two member Committee consisting of a former Chief Secretary, Delhi and Former Principal Chief Conservator of Forest (the latter was also formerly an expert member of the Tribunal). The Committee has to monitor the directions issued by the NGT with regard to pollution in the river Yamuna and the drains adjoining the river Yamuna.

The grievance in the present case relates to the Barapulla Drain. Since the NGT has set up a mechanism for monitoring its directions and has called for interim reports, it would be appropriate to direct that the grievance of the appellant be considered by the Committee which has been set up

by the NGT in the first instance.

We accordingly, permit the appellant to move the Committee and request the Committee to enquire into the grievance in terms of the directions which were issued by the NGT, as expeditiously as possible. Thereafter, it would be open to the appellant to pursue its rights and remedies in accordance with law, if it is aggrieved by any action or decision taken.

The Appeal is, accordingly, disposed of.
