Mr. Annanya Nayyar, learned counsel appears for the petitioner. He points out that despite service of notice, the respondent (husband) has failed to put in his appearance.

Learned counsel for the petitioner then refers to the Court's order dated 28.07.2020 to submit that the petitioner will face threat, if she proceeds to Mumbai to contest the Divorce case filed by the respondent.

It appears that the petitioner has claimed Maintenance and also filed proceedings under the Domestic Violence Act and Complaint under the Dowry Prohibition Act and all these proceedings are pending against the respondent, in Delhi.

Having considered the above and the fact that the respondent has failed to contest the Transfer Petition despite service of notice, I deem it appropriate to allow this Transfer Petition.

Consequently, the Petition No. 101446 of 2019 titled as

*"Darshan Bharat Churiwala v. Anika Darshan Churiwala Nee Anika Jain"*, pending before the Family Court, Bandra, Mumbai is transferred to the competent Family Court, Saket Courts Complex, New Delhi.

The Transfer Petition is allowed.
