**ORDER**

- 1 Since the proceedings under Sections 241 and 242 of the Companies Act 2013 are pending before the National Company Law Tribunal<sup>1</sup>, all that needs to be observed is that all the contesting parties have agreed that the proceedings be disposed of expeditiously and within a period of one month from the date of receipt of a certified copy of this order. In the event that the NCLT is unable to dispose of the main company petitions due to the exigencies of its own work, not bearing on the lack of cooperation by any of the contesting parties before it, it should take up the application for interim relief and dispose it of within the aforesaid period.
- 2 Subject to the aforesaid, the appeal is dismissed.
- 3 Pending applications stand disposed of.
