Five persons namely Rajendra Yadav @ Raju Yadav, Hari Yadav, Barhan Yadav, Ashok Yadav and Sukhdeo Yadav were found guilty of the offences punishable under Section 302 read with 149 of the Indian Penal Code and other subsidiary offences.

We have gone through the contents of the Review Petitions and do not find any error apparent on record to justify interference in Review Jurisdiction.

These Review Petitions are, therefore, dismissed.
