O R D E R

CrI.A. No.793/2020

1. Learned counsel for the respondent-State submits that appellant- Mehar Singh has died and the legal representatives intend to pursue the appeal.
2. Let application for substitution, in accordance with law, be positively filed within a period of four weeks.

CrI.A. No. 794/2020

1. I.A. No. 75304 of 2025 seeking grant of bail has been filed.
2. Considering the facts that the appellant/applicant is aged about 76 years old; he is in custody for more than eleven years and the role ascribed to him, we suspend the sentence of the appellant, pending consideration of the appeal, in connection with Sessions Case No.2 of 2009 for the offences punishable under Sections 302/34 IPC and enlarge him on bail on such terms and conditions as may be fixed by the Additional Sessions Judge (FTC), Karnal.
3. I.A. No.75304 of 2025 is allowed.
