



agreement/deed as apparently his father had never signed this agreement.

2. On the other hand, learned counsel for the appellants stated that a settlement has been arrived in 2018 and he had instructions from all the appellants to withdraw this appeal. It is relevant to note here that at the time when the settlement agreement/deed was signed, the appellant no. 1 was alive.

3. We are, accordingly, not inclined to accept the request made by the legal heirs of appellant no. 3. The appeal is, accordingly, dismissed as withdrawn.
