O R D E R

Heard Mr. Parnam Prabhakar, the learned counsel appearing for the petitioner (wife). Mr. G.V.R.Choudary, learned counsel appears for the respondent (husband).

At the very outset, the respondent counsel points out that the four year old son of the couple is staying with the father but it was wrongly submitted on the last occasion that the son is with the mother, in the parental home of the petitioner at Hyderabad. Responding to this, the petitioner's counsel points out to page 'C' of the petition to submit that it was specifically mentioned that when the petitioner fell sick and was alone at Hyderabad, the couple's son was forcibly taken away by the respondent's younger brother and accordingly, it is submitted that reflection in the court's order dated 16th September, 2020 could be on account of mis-communication.

The petitioner is working and residing in her parental home at Hyderabad whereas the respondent is in the Real Estate business and is based in Visakhapatnam. The proceedings at Visakhapatnam was stayed by this Court on 16th September, 2020.

Comparing the situation of the petitioner and the respondent and the other circumstances of this case, I deem it appropriate to allow this Transfer Petition. In consequence, the O.P. No.987 of 2019 titled as *Naveen Parvathaneni v. Swetha Parvathaneni* pending before the District and Family Judge Court at Visakhapatnam, Andhra Pradesh *is ordered to be transferred to a competent Court, Ranga Reddy, Hyderabad, Telangana.*

With the above order the case is disposed of.
