O R D E R

We have heard Mr. Abhishek Kumar, learned counsel appearing for the petitioner (Wife). Also heard Ms. Samridhi S. Jain, learned counsel appearing for the respondent (husband).

The counsel for the parties refer to the joint application being I.A. No.99442/2023 to point out that a settlement has been reached on 20.03.2023 through the efforts of the Mediator appointed by the Supreme Court Mediation Centre. In terms of the said settlement, all the financial transactions have been completed and Ms. Romila Munoth who is also virtually appearing in the proceedings has acknowledged the receipt of the amount mentioned in the settlement from the respondent. The pending cases mentioned in paragraph 2 of the Settlement Agreement dated 20.03.2022 are accordingly ordered to be closed/settled.

In view of the settlement reached between the parties, we deem it appropriate to invoke our power under Article

142 of the Constitution of India and order for dissolution of marriage by mutual consent between *Romila Sanjay Munoth* and *Sanjay Chandrakant Munoth*. A decree accordingly be drawn up to the same effect.

With the above order, the Transfer Petition stands disposed of.
