UPON hearing the counsel the Court made the following

O R D E R

IA No. 241599/2024

1. Heard Ms. Anubha Agrawal, learned counsel appearing for Unitech Ltd. and Mr. Mahesh Jethmalani, learned senior counsel appearing on behalf of New Okhla Industrial Development Authority (NOIDA).

2. The prayer in this application is to direct NOIDA to accord permission and approvals of lay out plans, building plans and ancillary approvals for three projects namely: (i) Sectors 96, 97 and 98, (ii) Sector 113, and (iii) Sector 117. The aforesaid

prayer has been made in furtherance of the orders passed by this Court previously on 26.04.2024 and 04.12.2024.

3. Mr. Mahesh Jethmalani, learned senior counsel submits that unless the outstanding dues of NOIDA are settled, the permissions and approvals sought by the Unitech cannot be granted.

4. We have considered the rival submissions. Considering the circumstances, NOIDA is directed to process the pending lay out plans, building plans and all other ancillary approvals and accord the necessary approval within two weeks without prejudice to its right to the determination, quantification and payment of outstanding dues. NOIDA may submit its claims before this Court within four weeks. The Unitech Ltd. may submit its counter reply within two weeks thereafter.

5. Post the application on 21.08.2025 for final determination and quantification of dues payable by Unitech Ltd. to NOIDA.

IA No.784/2025

1. There are two issues that arise for consideration in this application. One pertains to the alleged encroachment made by M/s. RDC Concrete (India) Private Limited (RDC) on the piece of land in the area at Uniworld City, Newtown, Rajarhat, Kolkata, namely, the site which belongs to Unitech Ltd. Notice was issued to RDC, however, no one has entered appearance.

2. In these circumstances, we direct the New Kolkata Development Authority (NKDA) to remove the encroachment made by RDC on the subject site within a period of three weeks.

3. The Commissioner of Police, Bidhan Nagar and the Collector of

that area, are directed to provide every logistical assistance as also the police force to NKDA for the removal of encroachment. A status report along with videography of removal of encroachments shall be produced before the next date of hearing.

4. Post the application on 21.08.2025.
