O R D E R

Having heard the learned counsel for the parties, the averments made in the transfer petition, and in the interest of justice, we allow the transfer petition.

Accordingly, Complaint Case No. 15290 of 2018, under the provisions of Protection of Women from Domestic Violence Act, 2005, pending in the Court of Metropolitan Magistrate, Mahila Court, Saket Courts, New Delhi is directed to be transferred to the court of the Presiding Officer, Mahila Court at District Court, Hyderabad, Telangana, who may hear the case himself or assign it to a court of competent jurisdiction.

Records of the case will be immediately transferred to the transferee court.

To cut short delay, parties are directed to appear in person, through an authorized representative or through video-conferencing if the said facility is available, before the transferee court on 21.02.2023. However, in case there is non-appearance, court notice will be issued to the defaulting party.

The parties may explore possibility of settlement through mediation. The transferee court will obtain the desire and wishes of the parties and proceed accordingly in this regard.

The transferee court will decide the matter expeditiously.
