Leave granted.

This appeal challenges the judgment and final order dated 27.01.2020 passed the High Court of Judicature at Allahabad in Criminal Misc. Bail Application No. 3880 of 2020.

The appellant is alleged to have committed offence punishable under Section 306 IPC and is facing prosecution in Crime No. 627/2019, registered with P.S. Kotwali, District Mathura. The appellant is in custody since 02.09.2019.

Learned counsel appearing for respondent-State submitted that the investigation is complete and charge sheet has accordingly been filed.

In the circumstances, we deem it appropriate to

grant the facility of bail to the appellant. Ordered accordingly.

The appellant shall be presented before the Trial Court within three days and shall be released on bail on furnishing cash security in the Sum of Rs. 50,000/- with two like sureties. The Trial Court is at liberty to impose such conditions as it deems appropriate to ensure presence and participation of the appellant in the trial and to see that no hindrance and interference is caused in the conduct of the proceedings.

With the aforesaid observations, the appeal is allowed.
