SLP(C) Nos. 5178,5208,,5169,5365,5180,5209/2020 and 8948/2021, 6775/2022

Service of notice is complete on all the respondents but none has entered appearance.

Today, Ms. Pratibha Singh, Ld. Advocate has entered appearance on behalf of Mr. Raj Kishore Choudhary, Ld. Advocate-on-Record for respondent Nos. 1 to 3.

Ld. Counsel seeks and is granted four weeks time to file vakalatnama and counter affidavit.

After expiry of four weeks, list the matter before the Hon'ble Court.

SLP(C) No. 9360/2022
