O R D E R

The petitioner-wife has filed the petition under Section 25 of the Code of Civil Procedure, 1908 before this Court seeking transfer of HMA Petition No.14 of 2019 titled "Deep Sharma Vs. Geetanjali" pending before the Principal Judge, Family Courts, District Shahdara, Karkardoma Courts, Delhi to the Principal Judge, Family Court, Ambala, Haryana.

In the instant case we notice that the efforts were made to settle but the same could not fructify in a settlement between the parties.

In that light, we are left with no option but to take note of the averments made in the petition and the objection statement. Having considered the same, we deem it appropriate to direct the transfer of case bearing HMA Petition No.14 of 2019 titled "Deep Sharma Vs. Geetanjali"

pending before the Principal Judge, Family Courts, District Shahdara, Karkardoma Courts, Delhi to the Principal Judge, Family Court, Ambala, Haryana.

In the facts of the present case, we grant liberty to the respondent to make an appropriate application before the transferee court to permit the respondent to take part in proceedings through virtual mode. If such request is made, the transferee court shall take note of the same and permit the respondent and insist on the personal presence only when it becomes absolutely necessary.

In terms of the above, the Transfer petition is allowed.

It is also made clear that the transferee court shall dispose of the proceedings within a period of six months from the date of the first appearance of the parties before it.
