Respondent Nos.2 to 11, 13, 14 and 16 pray for and are granted four weeks' time, as last opportunity, for filing counter affidavit.

Respondent No.18 has not filed counter affidavit, despite grant of final opportunity on the earlier occasion. Further opportunity to file counter affidavit stands declined.

Service is complete on respondent No.17 but none has entered appearance.

Petitioner has not taken appropriate steps in respect of respondent No.12, who is reported to be dead, despite grant of final opportunity on the earlier occasion. Petitioner has neither taken fresh steps nor filed fresh particulars in respect of respondent No.15 despite grant of final opportunity on the earlier occasion.
