O R D E R

Application being IA No.170166/2022 has been filed by the petitioners for amendment of the cause title and correct the name of the deceased petitioner no.13. The learned counsel for the petitioners states that the name of petitioner no.13 was wrongly typed as Meena Shekhar Shinde in the trial court, the High Court and before this Court. He further submits that the correct name of the deceased petitioner no.13 is Neena Shekhar Shinde as outlined in her death certificate.
