O R D E R

This transfer petition has been filed by the petitioner-wife seeking transfer of the divorce petition instituted by the respondent-husband, being Family Main Case No.642 of 2019 titled as "Raj Singh Charan vs. Pooja", pending before the Principal Judge, Family Court, Bhilwara, Rajasthan to the Principal Judge, Family Court, Hisar, Haryana.

By order dated 06.07.2020 notice was issued to the respondent. Office report dated 12.11.2021 indicates that notice issued to the sole respondent on 06.08.2020 has been returned back with remarks "insufficient address".

By order dated 27.11.2019 passed by the Registrar, fresh notice was issued to the respondent through District and Sessions Judge on 09.12.2020 and service report has been received from the District Court, Bhilwara stating therein that notice has been served on the respondent on 18.12.2020.

On 08.01.2021 the matter was listed before the Registrar's Court and service was held to be complete on the sole respondent and the matter was directed to be listed before the Court as per Rules.

Today when the matter is called out, no one has appeared on behalf of the respondent.

Having heard learned counsel for the petitioner, I am of the considered view that transfer of the proceedings, as prayed for, is warranted.

Accordingly, this transfer petition is allowed and it is directed that Family Main Case No.642 of 2019 titled as "Raj Singh Charan vs. Pooja", pending before the Principal Judge, Family Court, Bhilwara, Rajasthan shall stand transferred to the Principal Judge, Family Court, Hisar, Haryana.

The parties shall be at liberty to apply before the transferee Court for appearing through the video conferencing mode as also for expeditious disposal.

The records of the case be transferred to the transferee Court forthwith.
