This petition has been filed under Section 25 of CPC seeking transfer of Marriage Petition No.661/2018, titled as 'Harjot Singh Malhotra versus Rupsi Kaur Chawla' pending before the court of Civil Judge, Sr. Division, Pune, Maharashtra to the Family Court at Ranchi, Jharkhand. The said petition has been instituted by the husband seeking divorce and the petitioner before us is the wife.

Heard learned counsel for the parties. It is pointed out by the learned counsel appearing for the respective parties that no settlement could be arrived at by and between the parties.
