O R D E R

Heard the learned counsel for the parties and perused the petition papers.

By the Order passed by the High Court, the Writ Petition filed by the petitioner herein, seeking writ of Habeas Corpus has been dismissed.

As noted by the in High Court, a suit between the parties relating to the adoption of the child, is pending before the Trial Court in C.S. No.529/2019. In that situation, the High Court was justified in not entertaining the Writ Petition.

Further, a suit for declaration bearing C.S. No. 1171/2019 is also said to be pending before the Trial Court, Kharar.

Be that as it may since, the issue relating to the adoption of the child and the right being sought by the petitioner relating to the child is pending in the said suits and the suits were filed as far back as in the year 2019, we request the Trial Court to dispose of the suits as expeditiously as possible but not later than nine months from this date.

All contentions of the parties are left open to be urged in appropriate suit in accordance with law.

Petition is disposed of accordingly.
