These Special Leave Petitions are filed aggrieved by the interim order in pending First Appeal preferred under Section

74 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013. In view of the rival claims claiming compensation, we deem it appropriate not to allow withdrawal of compensation by any party till First Appeal itself is disposed of. We dispose of the Special Leave Petitions by permitting the parties to move High Court to file appropriate application for expeditious disposal of the First Appeal pending before it. If any such application is filed, we request the High Court to decide the First Appeal as expeditiously as possible.

With the aforesaid direction, the Special Leave petitions are disposed of.
