The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

A learned Single Judge of this Court in I.A.No.1 of 2020 in W.P.No.12372 of 2020, dated 10.08.2020, following the Division Bench Order in I.A.No.1 of 2020 in W.P.No.11735 of 2020, has granted interim orders on the ground that there is no privity of contract between the petitioner and the Superintending Engineer, Operation, TSSPDCL, Sanga Reddy/respondent No.2. The facts in the present case are also similar to the facts in the above mentioned writ petitions.

In view of the same, this Court is of the prima facie opinion that there is no privity of contract between the petitioner and the respondent No.2, and there is no adjudication of the differential wheeling charges by any authority, and therefore, there shall be an interim suspension, as prayed for.
