Petition under Section 151 of CPC, praying that in the circumstances stated in the affidavit filed in the writ petition, the High Court may be pleased to direct the Respondents to examine the petitioner's representation/appeal submitted by the Petitioner Dt. 07/01/2022, 11/01/2022 and 12/01/2022 for posting and joining at the allotted place, pending disposal of WP No. 7234 of 2022, on the file of the High Court.

The court while directing issue of notice to the Respondents herein to show cause as to why this application should not be complied with, made the following. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

"Heard learned counsel for the petitioner and learned Government Pleader for Services appearing for respondents and perused the record.

Since aggrieved by the impugned proceeding dated 23.12.2021, petitioner claims to have filed representation to the 3rd respondent on 07.01.2022 and to the 1st respondent on 12.01.2022 for allotting her to the local cadre of Yadadri-Bhuvanagairi District, without considering that the petitioner's case falls under spouse category and her husband has been allotted to the local cadre of Nalgonda District. Pending further orders, the respondents 3 & 1 are directed to dispose of the said representations on or before 21.04.2022, in accordance with law, and communicate their decision to the petitioner.

It is made clear that while considering the appeal, the respondents shall keep in consideration the intent and purport behind the Circular instructions issued vide Memo No.1655/SPF-I/2021-8 dt.24.12.2021 by the Chief Secretary to Government relating to posting of employees in newly allotted cadre under Spouse Category."
