Petition under Section 151 of CPC R/w Section 36 A&C Act, 1996 praying that in the circumstances stated in the affidavit filed herein, the High Court may be pleased to stay the award passed by the Respondent No.2 vide Award dated 24/05/2021 confirmed by II Addl. Chief Judge, City Civil Court, Hyderabad vide order dated 28/04/2022 and restrain the Respondent No.1 from withdrawing the amount of Rs.10,75,223/- (75% of the Award Amount) deposited vide DD No.083441 dated 24/08/2021, as a prerequisite under Sec. 19 of the MSMED Act, 2006 to file an appeal under Sec. 34 of Arbitration and Conciliation Act, 1996, pending disposal of CMA.No. 386/2022 on the file of the High Court.

The Court while directing issue of notice to the Respondents herein to show cause why this petition should not be complied with, made the following order. (The receipt of this order will be deemed to be the receipt of notice in the case).

ORDER:

“ Counsel for the appellant/petitioner submits that the respondent is directed to withdraw the amount.

Even if the appeal is decided in favour of the petitioner, purpose would not be served.

However, while ordering notice to the respondent, implede stay is granted till 12-09-2022.”
